SHOW APPROVAL DEADLINE: IQHA application is due when AQHA show approvals are submitted and follow AQHA rules. A deposit of \$250 must be submitted with this application. Deposit will be refunded when all IQHA requirements are met (see below). Deposit will be forfeited if requirements are not met. NOTE: All show approval forms for a "circuit" must be received before the dates will be published as approved. Once all the show approval forms for a circuit are received, and required memberships are paid, your dates will be published as IQHA-approved shows. No showbill will be advertised in IQHA sources until show approval is complete.

- We agree to provide IQHA with a Certificate of Insurance listing IQHA or obtain insurance with the policy IQHA currently has in effect by completing the requested information (last page) and returning with appropriate fees with this show approval request. IQHA District Shows are provided insurance free of charge but must complete the insurance request form.
